AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Lacey Fire District 3 from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- Financial condition
- Procurement
- Credit cards
- Self-insurance - unemployment

INFORMATION ABOUT THE DISTRICT

Thurston County Fire Protection District No. 3, doing business as Lacey Fire District 3, was created in 1948. The District serves an area covering approximately 70 square miles and serves 95,000 residents in Thurston County. The District provides fire and life safety services through emergency response, education and code enforcement. One major point of emphasis in 2016 was to roll out an innovative new approach to CPR training, which leverages a “virtual reality” platform in order to give participants a very engaging and realistic experience.

An elected, five-member Board of Commissioners governs the District since the annexation of the City of Lacey in 2010. Board Members serve staggered, six-year terms. The Board appoints a Fire Chief to oversee the District’s daily operations as well as its 110 full-time firefighters, paramedics, administrative employees and 50 volunteers. For 2015 and 2016, the District operated on annual general fund budgets of approximately \$18.8 million and \$19.3 million, respectively.
