F. Community Outreach

Chief Cerovski shared:

- Chris DeBell reports that crews have visited two different day camps and an upcoming neighborhood block party. There is a Jubilee annual health fair on August 27th. The final LPD Summer Cruising event will take place next Wednesday. There have already been two so far and those have gone well. Preparations are underway for EMS standby crews for the high school football

games coming up this fall. There have been several car seat checks in the last few weeks. There are plans in the works for October Fire Prevention Month school visits. Safe Kids has donated more bicycle helmets and pads.

G. Capital Facilities and Equipment Activities

Chief Cerovski shared:

- There was a visit with the architect and Lacey staff. Expecting to see final documents for the VRF expansion the end of August. As soon as that is done, final contract documents will be ready for the bidding process. Hopeful of having a contractor selected within 6 to 8 weeks from the beginning of September.

VI. OLD BUSINESS

A. COVID Emergency Declaration status – staff report:

The COVID response has switched to members that have either been exposed or infected to contingency. There has been an uptick with members' family members. Looking at how to safely bring the members back to work. Under contingency, if a person goes 5 days without a negative test, if they are asymptomatic or mild to moderate illness, they can come back to work. If they are exposed and they are up to date, there are no work restrictions, just monitoring for symptoms. If they are not up to date (not vaccinated and/or not boosted) they would have to test every morning before starting their shift. There are very specific guidelines from the CDC, which are phase 1, 2, 3, 5, and 7. These don't really work with shift schedules, so for every single shift, they would be doing that. The reason for entering contingency mode again is because of the uptick and specifically with medic staffing.

Chief Cerovski reported:

- With regard to costs related to the FEMA COVID reimbursement process: there were some updates from the last billing cycle.
- The 2022 WFCMA Commissioner Conference invitation is open, October 27th through 29th.
- On the 14th, the State Fire Memorial took place in North Bend. Chief Brooks, Chief Cerovski, Lieutenant Green, Firefighter Lowe, and Firefighter Davenport attended. This was a ceremony that honored firefighters that have fallen in the line of duty since 2017. There were 25 firefighters from the state honored, one of whom was Firefighter Crystal Murphy. The family could not attend, but the aforementioned attendees accepted the plaque in lieu of the

family. It will be posted on the wall soon for a short time before being transferred to the family.
